

**THE COUNT'S HALLOWEEN SPOOKTACULAR 2024
COSTUME CONTEST OFFICIAL RULES - PARK ADMISSION NECESSARY**

1. Contest is open only to citizens and legal permanent residents of the 50 United States and the District of Columbia (excluding the state of Arizona). Contest is void where prohibited. Contest is open to all ages. Adults (individuals age 18 and older) may not enter best child category. Any costume, which in the judges' opinion is considered offensive or in poor taste, or does not meet any other pre-requisite for entry will be considered ineligible.
2. To enter, you must register. Registration deadlines apply. Registration will take place on October 27, 2024, beginning at 10:00 AM Pacific Time ("PT") on the Contest Date at the registration table in the Plaza area of 2052 Entertainment Circle, Chula Vista, CA 91911. Registration concludes on Contest Date at 11:30 AM. The Best Child category will be limited to the first 70 children to register on Contest Date. The Best Family category will be limited to the first 30 families to register on Contest Date. An entrant must have registered on the applicable Contest Date to be eligible to win on such Contest Date. Entrants are limited to one prize per entrant per category per Contest Date. The contest will be held in Sesame Place Theater at the following times on the Contest Date: Best Family category: 11:30 AM – 12:30 PM PT; Best Child category: 12:30 PM – 1:30 PM PT. A family is defined as a group of two or more people consisting of at least one child under the age of 18 and one parent or legal guardian.

4. Costumes will be judged on Contest Date by a panel of judges, based on the judges' personal assessment of creativity (33.34%), execution (33.33%) and audience appeal (33.33%). In case of a tie, tied entries will be based solely on creativity. On Contest Date, six winners will be chosen, 3 from each category in 1st, 2nd and 3rd placements. Categories include Best Child and Best Family. Entrants must be present to win. Potential winners of the contest held on each Contest Date will be announced on such Contest Date. Decisions of the judges are final and binding. Winners may not substitute or transfer a prize but Sponsor (defined in Section 13 below) reserves the right to substitute a prize with a prize of equal or greater value.
5. Potential winners may be required to complete, sign and return an affidavit of eligibility and liability and publicity release within 5 days of prize notification. Parents or legal guardians of any and all minor entrants (each, a "Minor Participant") may be required to complete, sign and return an affidavit on behalf of each Minor Participant. In the event of noncompliance within this time period, prize will be forfeited and an alternative winner will be selected. A list of winners for each contest will be announced and/or posted at Guest Services and at Sesame Place Theater by 1:30 PM PT on the applicable Contest Date.
7. Employees and immediate family members of employees of Sponsor, Sesame Place, Sesame Workshop, and their affiliates, subsidiaries, advertising and publicity agencies are ineligible. This contest is void where prohibited by law, and is subject to federal, state, and local regulations. Taxes on prizes, if any, are solely the responsibility of the winner.

First Place Family (1 prize awarded): 2024 Sesame Place A Very Furry Christmas single day admission ticket, an Unlimited Magic Queue and theater show reserved seating (up to 6 family guests); Second Place Family (1

prize awarded): 2024 Sesame Place A Very Furry Christmas single day admission ticket and Reserved Parade Viewing for one (1) performance of the Neighborhood Street Party Christmas Parade (up to 6 family guests); Third Place Family (1 prize awarded): 2024 Sesame Place A Very Furry Christmas single day admission tickets (up to 6 family guests).
